If necessary, written tests and assignments may also be conducted before the panel interview. In case of tie at any stage all the candidates who have same marks will be considered to have qualified for further rounds.
- b. Candidates having more than one eligible qualification shall have to choose only one for selection process.

Selection Criteria: The selection will be based on the basis of weightage of marks in Qualification, Experience in the relevant field, performance in the Interview and Skill test. Criteria for awarding marks is as follows: (it may change as per requirement and available candidates)
