On behalf of the Director, Central Arid Zone Research Institute, Jodhpur online tenders are invited for Annual Job Contract for engagement of agency for providing cleaning services on outsourcing basis for a period of one year depending upon the requirements of the ICAR-Central Arid Zone Research Institute's RRS Pali from time to time as per the terms and conditions set forth in the following paragraphs. The Services of the manpower agency would be required initially for a period of one year. The period of ARC can be extended further subject to satisfactory compliance of terms and conditions of the contract.
- Tender form and terms & conditions can be downloaded free of cost from the website http://eprocure.gov.in and www.cazri.res.in upto 11.30 hours of 03.07.2019. On-line bids complete in all respects should be submitted through CPP Portal http://eprocure.gov.in/eprocure/app only by or before the last date and time i.e. 04.07.2019 upto 11.00 a.m.
- 3. Tenderers/bidders are requested to visit the website http://eprocure.gov.in/eprocure/app regularly. Any changes/modifications in tender enquiry will be intimated by corrigendum through this website only.
- 4. In case, any holiday is declared by the Government on the day of opening, the tenders will be opened on the next working day at the same time. The Director, ICAR CAZRI reserves the right to accept or reject any or all the tenders.
- 5. The interested Firms {except those who are registered with the Central Purchase Organization & National Small Industries Corporation (valid proof should be mandatory enclosed)} are required to deposit (in original) an Earnest Money Deposit (EMD) of Rs. 8000/- (Rupees eight thousand only) and Tender fee Rs. 500/- (Rupees five hundred only) in the form of Demand Draft from any of the Commercial Bank in India, in favour of "ICAR Unit CAZRI, Jodhpur". The bidder must have current Income Tax/ Service Tax and statutory registration(s).
- 6. - 9. Decision of the Director, ICAR CAZRI, Jodhpur shall be final for aspect of the contract and binding on all parties. Dispute arising, if any, on the contract will be settled at his/her level by mutual consultation.
- 10. Bidders/tenderers shall undertake to the apply with all statutory provisions are required for such man power to be provided including Minimum Wages Act, EPF, ESI, Service Tax etc. as required under law and shall indemnify CAZRI from all libels/suits/litigations etc.
- 11. The Contractual Agency shall take all responsibility and obligation for providing man power engaged by him for the purpose at ICAR CAZRI's RRS, Pali. ICAR CAZRI's RRS, Pali will not be responsible for any libels/suits/litigation or otherwise/obligation/commitment/liability to any party (ies) or persons(s) whatsoever.
- 12. SECURITY OF CONTRACT: The Contractual Agency shall provide Security in the form of DD/Bank Guarantee/FDR in favour of ICAR Unit, CAZRI payable at Jodhpur-342 003 for contract period as would be specified in the work order to be awarded to the successful bidder for 10% of total vaule of Annual Rate Contract and execute an agreement before starting the contract. The Security money will be released only after the termination/expiry of the contract. The Security money deposit should be valid up-to 3 months beyond the date of expiry of the contract.
- 13. No interest on Security deposit and earnest Money deposit shall be paid by the ICAR CAZRI to the bidder.
- 14. Service tax / GST or any other tax applicable for made applicable after awarding the contract in respect of this contract shall be payable by Contractual Agency. ICAR CAZRI's RRS Pali will not entertained any claim whatsoever in this respect. GENERAL INFORMATION & OTHER TERMS & CONDITIONS OF THE CONTRACT FOR PROVIDING <u>ELECTRIC</u> <u>MAINTENANCE & REPAIR WORK</u> (ICAR-CAZRI, REGIONAL RESEARCH STATION, PALI)

SCOPE OF WORK:

ABOUT THE INSTITUTE & STATION: Central Arid Zone Research Institute, Jodhpur is a premier research organization under the aegis of ICAR (Department of Agricultural Research and Education, Govt. of India) and RRS, Pali is one of the its Regional Research Stations RRS). The station is located in the total area of 454 hectares, which includes all the Residential, Non Residential building and experimental/ Farm area. At present the Rajasthan State Electricity Board has calculated/ assessed its total electrical consumption requirement to be around 40 KW under mix Load L.T. All the residential area and office buildings are provided with usual electrical connection/ sockets without any exorbitant/heavy electrical fittings. However, laboratories/ farm sections have some sophisticated scientific/analytical/equipment's and machines, which are operated as and when needed and are not being used simultaneously under any condition.

(A) RESIDENTIAL BUILDINGS: Presently there are about 21 numbers of quarters in Pali in this Station of different categories. The concerned contractor would be completely responsible for ensuring rectification/repairing electrical faults/problems/failure in all the residential quarters as mentioned above. Accordingly, the contractor would also be responsible for proper repair and maintenance works and will attend electrical problems in respect of Guest House, HEAD's Bungalow, Street Lights etc. at the Institute/ campus including repairs/maintenance and upkeep of Power factors/Panel etc.

(B) NON-RESIDENTIAL BUILDINGS: The Non-residential buildings of the Institute include the Main distribution board, Main Building distribution board/panel up to main distribution board/panel of the office building. Maintenance of panel boards installed at Open wells (2 Nos.) and one (01) pumping station for water supply to residential area/Maintenance of overhead electrical lines and L.T. cable ranging from 10 sq.mm to 300 sq. mm connected to office buildings, residential buildings, land, pumping sets including that of street/road lights of the Institute including repairs/maintenance and upkeep of L.T. Cables, Power factors/Panel etc.

(C) REPAIR/MAINTENANCE OF FANS: Carrying out the Repair/maintenance (greasing, overhauling etc.) of all ceiling fans and exhaust fans (around 90 Nos.) existed in above A and B buildings will also be the responsibility of the contractor. The electrical materials required as chocks, tube lights, wire, switches, sockets, bush bearings, capacitor and rewinding and machining work etc. would be provided by the Institute.
