## (Tender Document for inviting acceptance for supplying POL items on credit basis)

Subject : Tender Enquiry/quotation for engaging the firms for supplying the POL items on credit basis - regd.

Dear Sirs,

I am directed to invite you to submit your acceptance in the format enclosed herewith (annexure - I) for supplying the P.O.L. items (normal diesel & petrol, etc.) on credit basis on the following terms and conditions:

- i. All the P.O.L. items (normal diesel & petrol, etc.) will be supplied by the firm at the rate fixed by the Govt. from time to time. Discount/Rebate, if any on the POL items may be mentioned by the supplier on submission of their offer/quotation.
- ii. The firm has to supply the Petrol, Diesel & Lubricants on production of slip duly signed & stamped by the authorized officer of ICAR-CAZRI as & when required.
- iii. No cash payment will be made for supply of POL items to the Institute. The payment will be made by the Institute through DD or Cheque or through electronic mode for the ordered supply POL items within 15 days from the date of receipt of credit bill(s) with a copy/list of approved rate(s) of Govt./Oil Companies for Jodhpur city for supplied P.O.L. items) from the firms for which the firm will produce the pre-receipted bill in duplicate fortnightly for arranging the payment.
- iv. The supplier shall execute a legal contract agreement on a non-judicial stamp paper of worth Rs. 500.00 (charges to be borne by the supplier) within 21 days of the issue of letter of acceptance.
- All disputes will be subject to the exclusive jurisdiction of competent Courts and Forums ٧. in Jodhpur only.

- vi. The Supplying Contracts shall be valid for the period of one year from the date of awarding the Contracts. The contract period may be extended for further period depending upon requirements with mutual consent/agreement. However the Director, ICAR-CAZRI reserves the right to reduce the period of Rate Contract/terminate/cancel the Rate Contract at any time (before expiry of Rate Contract) without assigning any reason thereof. The Supplying Contract awarded as a result of this Tender Enquiry will be in the nature of a Standing offer. <u>Actual Supply Order may be placed from time to time</u>. No guarantee can be given as to the minimum or actual services usage.
- vii. CAZRI reserves the right to conclude parallel supply Contracts with a number of suppliers and place Orders on any of such firm that may be the most economical to it or suitable to its requirements / nearest distance from the Institute etc.
- viii. In case the firm does not complete the supply or deny to supply the (normal diesel & petrol, etc.) within delivery period, action will be taken against the firm to recover from the contractor as agreed liquidated damages including administrative expenses and not by way of penalty a sum equivalent to 2 % per week of the price of any stores which the contractor has failed to supply within the period fixed for delivery of such stores. Where delivery thereof is accepted after expiry of the aforesaid period, the total damages so claimed shall not exceed 10% of the total price of stores required.
- ix. The Director, ICAR Central Arid Zone Research Institute, Jodhpur has right to terminate the contract at any time in case of breach of conditions stipulated herein in this agreement.
- x. The firm to whom award the contract will have to supply the P.O.L. etc. on credit basis at least for 15 days.
- xi. The firm who situated nearest distance from the Institute Work-shop and P.O.L. items to be supplied on credit basis will be given priority. In case both the conditions matches with the firms then the firm who offered higher rate of discounts on allied P.O.L. items will be preferred for award of contract.
- xii. The quotation may be sent to the office by courier/Regd. Post/speed post in sealed cover Super scribed with "quotation for supply of P.O.L." due date 17.08.2017 and the same must be reached to this office on or before 17.08.2017 at 3.00 p.m. failing which it will not be considered. The quotation should be dropped in the Tender Box placed in the Admn. IV Stores Section (with AAO, IV). The quotation will be opened on the very same day i.e. on 17.08.2017 at 3.30 p.m. in presence of representative of the firm, if they desire to attend.

2. The Director, ICAR - CAZRI reserves the right to accept or reject any or all tender without assigning any reasons thereof.
