


Instructions for Online Bid submission

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: https://eprocure.gov.in/eprocure/app.

REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS

- 1) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3) Bidder has to select the payment option as "offline" to pay the tender fee / EMD as applicable and enter details of the instrument.
- 4) Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.

- 5) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- 6) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 7) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid openers public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 9) Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 10) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

ASSISTANCE TO BIDDERS

- 1) Any queries relating to the tender document and the terms and conditions contained therein should be addressed to the Tender Inviting Authority for a tender or the relevant contact person indicated in the tender.
- 2) Any queries relating to the process of online bid submission or queries relating to CPP Portal in general may be directed to the 24x7 CPP Portal Helpdesk.

Terms and Conditions

- 1. The tenderer shall quote rates, which will include the delivery (supply and installations)& other incidental charges. Taxes, if any, should be indicated separately.
- 2. The rates should be quoted as per the Financial Bid /BOQ format uploaded on the CPP Portal. Taxes, if any, should be indicated separately. It must be noted that the contract shall be awarded to the firm which fulfils all the required specifications, terms and conditions and remains L-1.
- 3. The firm must also possess valid PAN No., TIN No. & GST registration number and a copy of the same must also be enclosed with the tender document.
- 4. Copy of Income Tax Return of last 2 years may be furnished.
- 5. Modification in the tender documents after the closing date and time is not permissible.
- 6. The successful firm shall have to supply the <u>item (from the date of confirmed supply order)</u> within 30 days /as mentioned in the supply order(P.O.) and if the materials are not supplied and installed in time then EMD shall be forfeited. The rates quoted shall be valid for 6 months from the date of opening of tender.
- 7. The contractor/bidder or his representative may contact the undersigned at Tel No.0291-2787152 for any further clarification. No variation in terms of quality of the items shall be entertained or else EMD/Security deposit shall be forfeited.
- 8. The Director, ICAR-CAZRI, Jodhpur shall have the right to reject all or any of the offers, accept more than one offer, and assign part of the job.
- Merely quoting of lowest rates does not mean that order shall be given to that firm. The
 competent authority will finally decide on the basis of quality & performance of past
 installations.
- 10. The interested Firms are required to deposit/submit (in original) Tender fee (not refundable) and an Earnest Money Deposit (EMD) of the amount mentioned in Critical date sheet in the form of Demand Draft/Bankers cheque/Pay order from any of the Commercial Bank in favour of "ICAR Unit-CAZRI, Jodhpur", payable at Jodhpur may be addressed to Director, ICAR-CAZRI, Jodhpur on or before bid submission closing date and time as mentioned in critical date sheet. No quotation/tender shall be considered without the earnest money deposit. Demand Draft drawn in favour of any officer other than "ICAR Unit-CAZRI, Jodhpur" payable at Jodhpur' will not be accepted and the tender will be rejected. The earnest money will be refunded only after the finalization of the procurement and no interest will be paid on earnest money.

- 11. Rates once finalized will not be enhanced/reduced during the currency of the contract.

 In case of foreign currency, conversion rates in INR will be taken on that day when financial bid will open.
- 12. In case, the successful bidder shows inability at any stage, after the contract is finalized and awarded, for whatsoever reason(s), to honour the contract, the earnest money / performance security deposited would be forfeited.
- 13. The Director, ICAR-CAZRI, Jodhpur reserves the right to cancel the contract at any time during the currency period of the contract without giving any reason.
- 14. The firm to whom the tender will be awarded, will have to deposit the performance security equal to 5% -10% of the total amount at the time of installation of the equipment. If the services are not found to be satisfactory, the performance security is liable to be forfeited. No interest will be paid on performance security.
- 15. If any dispute(s) arises between ICAR-CAZRI, Jodhpur and the firm with reference to the contract, ICAR-CAZRI, Jodhpur will decide it and its decision will be binding on the firms.
- 16 Bid Validity: 90 days.
- 17. The contract will be given to Least one (L1).
- 18. The Institute is exempted from payment of excise duty if any. Hence, excise duty will not be paid to the firm.
- 19. Payment-

100% of the contract price on receipt of goods as per specifications by the consignee supported by satisfactory installation/working report.

21. Installation: Should be done within stipulated delivery period as per the order at the Institute in consultation with the indenting officer, failing which Liquidated Damage clause shall apply. Liquidated Damage clause: It would be realized @ 0.5% (half per cent) of the base price (excluding taxes) of the delayed goods for each week of delay subject to maximum 10%.

22. Price -

- i) The price quoted shall be on firm and fixed basis and should be reasonable living no scope for any further negotiation on price.
- ii) For goods manufactured in India/abroad: The price of the goods should be quoted on FOR basis and in INR (including all kind of charges and taxes) installations commissioning charges, if any.
- 23. **Jurisdiction of Court** :- The court of the Jodhpur shall have a jurisdiction to decide any dispute arising out of or in respect of contract.
- 24. Force Majeure Clause: The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure. For purposes of this Clause, "Force Majeure" means an event beyond

the control of the Supplier and not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods. Epidemics, quarantine restrictions, strikes, lockout or any act of war. Notice of the happening of any such event is given by either party to the other within 15 days from the date of occurring thereof. However either party at its discretion can terminate the contract in such cases.

- 25. **Termination of Contract**:- Time shall be the essence of the contract. The purchaser shall have the right to terminate the contract without any notice in part or in full in any of the following cases:
 - a) The delivery of the material is delayed for causes not attributed to Force Majeure after the scheduled date of delivery.
 - b) The seller is declared bankrupt or becomes insolvent.
 - c) The delivery material is delayed due to causes of Force Majeure by more than reasonable time.
 - d) In case Performance Security is not furnished within the time period specified by the purchaser.
 - e) Supply in the case of successful Tenderer should strictly confirm to the specifications of the equipment being purchased.
 - f) Any change in Address/Telephone/Fax/e-mail of the tenderer should immediately be informed. The state of non-communication by the firm will make the offer liable for rejection.
- 26. Acceptance or rejection of offer :- The Director, ICAR-CAZRI, Jodhpur reserves the right to accept or reject any tender in part or full without assigning any reason thereof. The successful bidder should submit order acceptance letter within 10 days from the date of issue.
- 27. The firm to whom awarded the contract for the supply and installation of Seed Storage Unit will have to execute an agreement on appropriate value of non-judicial stamp paper in respect of the same.

TECHNICAL BID Schedule to tender

Technical Specifications for Supply and Installation of Seed Storage Unit at ICAR-CAZRI, Jodhpur

- 1. Walk in seed storage chamber of 800 cuft (10X10X8 ft) size.
- 2. Temperature Range: 2°C to 6°C±1°C
- 3. Relative Humidity: 40 to 60%.
- 4. Walls- 60mm puff insulated structure having inner side made of stainless steel 304 grade and PPGI on outside.
- 5. Cam lock arrangement with corner panels for leak proof cabinet must be provided.
- 6. Floor- 60mm thick puff insulated flooring covered with 1.2mm aluminium chequered sheets.
- 7. Door size: 2mX1m- right hand swing type overlap door fitted with imported hinges and door closer/posi seal closure, should have one glass viewing window.
- 8. Door lock must be fitted with internal safety release mechanism against accidental locking from inside along with human trap alarm.
- 9. Cooling system-two independent cooling systems each having 10000 BTU cooling capacity @ -5°C evaporating must be provided, so that one unit runs while other is maintained as standby.
- 10. Desiccant based dehumidifier with driers for better dehumidification.
- 11. Powder coated wheel mounted steel rack arrangement with working shelves along the three sides of chamber for storage of seeds must be provided. Six (6) racks of 48"X18"X72" size having 5 working shelves equally divided must be provided, provision for shelf height adjustment must be provided for change as per use.
- 12. Microprocessor based control panel for automation for TEMPERATURE AND HUMIDITY duly fixed with L&T/Havells make contractors and miniature circuit breakers with rigid standard of safety must be provided.
- 13. Microprocessor based programmable data logger having accuracy: +/- 2.0% Rh and +/- 0.3°C temperature and inbuilt real time clock calendar with lithium battery (Back up min 10 Years) must be provided.
- 14. High quality ISI approved fittings with copper multi strand twisted FR grade cable and rigid standards of safety with proper M.C.B. (Make L&T/Havells) With standard LED light illumination in chamber duly fitted in IP65 enclosures.
- 15. Warranty: One year against i) all spare parts ii) electronic & electrical instruments iii) manufacturing defects.
- 16. Trouble free after sales service must be provided within 24-48 hrs of intimation of complaint.

- 17. Firm must be ISO 9001:2015 as well as CE certified, documentary proof must be attached.
- 18. Detailed specification needs to be given for each section in technical bid with complete elaboration of technical requirements with all commercial terms and conditions failing which tender will be rejected.
- 19. Firm must have completed atleast two work orders of walk in seed storage/cold chamber/similar work during last two years, documentary proofs must be attached with contact details of client.
- 20. Drawing of tentative structure must be provided.


